**WHEREAS**, Atty. Marnel Muñoz first came to serve the people of Bacoor in 1997 when he was elected as a Barangay Kagawad of Barangay Queen's Row West. On 15 August 2002, Atty. Muñoz was elected as the Punong Barangay of the same barangay, a position he held until 30 November 2013.

**WHEREAS**, in 2014, former Mayor Strike B. Revilla appointed Muñoz to concurrently head the now defunct Urban Development Housing Office while performing the functions of the Public Employment and Services Office because of his experience in mitigating the plight of informal settler families when he was still a barangay official.

**WHEREAS**, Atty. Muñoz was appointed as the Local Civil Registrar of the City of Bacoor in 2017 by Mayor Lani Mercado- Revilla.

**WHEREAS**, in 2018, he realized a childhood dream when he passed the Philippine Bar Exams at the age of 52.

**WHEREAS**, in all his years as a public servant, Atty. Muñoz became known for his generosity of spirit, hard work, and readiness to help anyone who needed his assistance.

**WHEREAS**, on 10 October 2021, Atty. Muñoz died suddenly while confined for an undisclosed illness at the age of 55. He was survived by his wife Winnie Rose Amor Muñoz and by his children.
