A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR-EMB), FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACORR REGARDING THE CREATION OF THE MULTIPARTITE MONITORING TEAM (MMT), ENVIRONMENTAL MONITORING FUND, AND ENVIRONMENTAL GUARANTEE FUND FOR THE 90-HECTARE BACORR RECLAMATION AND DEVELOPMENT PROJECT.

WHEREAS, the Department of Environment and Natural Resources (DENR) and the Environmental Management Bureau (EMB) are the primary government agencies responsible for the conservation, management, development and proper use of the country's environment and natural resources;

WHEREAS, pursuant to Presidential Decree No. 1584, the City Government of Bacoor has been issued an Environmental Compliance Certificate (ECC) with Reference Code number 1909-0023 on December 21, 2020 for its proposed 90-Hectare Bacoor Reclamation and Development Project;

WHEREAS, the DENR issued Administrative Order No. 2017-15 and DAO 2018-18 which nationalized the composition and operation of Multipartite Monitoring Teams (MMT) in relation to reclamation projects;

WHEREAS, a draft Memorandum of Agreement was submitted by the Office of the City Legal Service with the authority of the City Mayor to the Sangguniang Panlungsod for review and consideration;

WHEREAS, under the draft MOA, the MMT shall be comprised of the following:

WHEREAS, the Sanggunian reviewed the terms and conditions of the said draft MOA and found its provisions as neither contrary to law nor disadvantageous to the government.


