**WHEREAS**, on 1 October 2021, the City Legal Officer, Atty. Bernadette Carrasco, sent a letter requesting the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla to sign a Memorandum of Agreement with Hisada Institute, Inc. for and on behalf of the City Government of Bacoor pertaining to the implementation of the Training for Work Scholarship Program (TWSP) for Contact Center Services NC II;

**WHEREAS**, under the proposed agreement, Hisada Institute, Inc. will provide free training to qualified Bacoor City residents and will endorse them to Business Process Outsourcing (BPO) companies and to other call centers to ensure employment of the qualified beneficiaries/trainee as competent contact center agent or provider;

**WHEREAS**, Hisada Institute, Inc. will collaborate and work together with the City Government of Bacoor for the full implementation of the TWSP to achieve at least 80% to 100% rate of employment;
