A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE RECLAMATION AUTHORITY FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR ON THE PROPOSED RECLAMATION OF 100 HECTARES OF THE OFFSHORE AREAS OF BACOOR BAY IDENTIFIED AS THE DIAMOND RECLAMATION AND DEVELOPMENT PROJECT (DRDP).

WHEREAS, on 04 November 2021, the City Legal Officer, Atty. Bernadette Carrasco, sent a letter requesting the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla to sign a Memorandum of Agreement with Philippine Reclamation Authority (PRA) regarding the proposed reclamation of 100 hectares of the offshore areas of Bacoor Bay identified as the Diamond Reclamation and Development Project (DRDP).

WHEREAS, the DRDP was approved by the PRA Governing Board – which was empowered by President Rodrigo Duterte to approve reclamation projects pursuant to Executive Order No. 74 issued on 01 February 2019- after the city government submitted to the PRA all the requirements for the project including the Area Clearance (AC) and Environmental Compliance Certificate (ECC) issued by the Department of Environment and Natural Resources (DENR) for the First Phase of BRDP.

WHEREAS, the City Government of Bacoor and the Diamond Export Corporation entered into a Joint Venture Agreement on December 20, 2018 for the rawland reclamation and horizontal development of the DRDP.

WHEREAS, a draft Memorandum of Agreement was submitted by the Office of the City Legal Service with the authority of the City Mayor to the Sangguniang Panlungsod for review and consideration;





