WHEREAS, on 01 July 2019, the Sangguniang Panlungsod passed City Resolution No. CR 2021-051 entitled: "A Resolution Adopting The Revised Internal Rules of The Fourth Sangguniang Panlungsod of City of Bacoor (2019-2022) In Compliance With Republic Act No. 9485 (The "Anti-Red Tape Act Of 2007) As Amended By Republic Act No. 11032 (The "Ease Of Doing Business And Efficient Government Services Delivery Act Of 2018"), Reorganizing The Sangguniang Panlungsod, And For Other Purposes".

WHEREAS, under Rule VII, Section 34 of the **Revised 2019-2022 Internal Rules of the Sangguniang Panlungsod of the City of Bacoor** states that "**NO SESSIONS DURING HOLIDAYS; CHRISTMAS BREAK.--** No regular session shall be held on official non-working holidays.
