WHEREAS, the Office of the City Accountant and the Office of the City Treasurer certified that there is enough funds to purchase the above-mentioned vehicles and it was allocated under the following budgets:

- City Health Office - under Annual General Fund Budget through Appropriation Ordinance No. CO 56-2019 dated December 2, 2019;
- City Social Welfare and Development Office - under Annual General Fund Budget through Appropriation Ordinance No. CO 136-2020 dated November 23, 2020; and
- City General Service Office - under Annual General Fund Budget through Appropriation Ordinance No. CO 43-2018 dated November 12, 2018.

WHEREAS, the purchase of the said vehicle units shall enhance the ability of the city government to deliver basic services to the public.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the Body in regular online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the purchase of motor vehicle units for the City Health Office, City Social Welfare and Development Office and General Services Office of the City Government of Bacoor. **Provided that:** the said purchase conforms with the DILG Memo Circular No. 2021- 004 dated 18 January 2021 and – as part of the austerity measures being implemented by the city government to maximize the use of limited public funds for the greater good.

RESOLVED FURTHER, to authorize the City Mayor to sign all agreements or documents related to the said purchase that complies with the foregoing conditions.

RESOLVED LASTLY, to furnish the DILG, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
