A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND THE BUREAU OF FISHERIES AND AQUATIC RESOURCES FOR THE DRAFTING OF THE MARINE SPATIAL PLAN FOR INTEGRATED AND SUSTAINABLE EFFORT TO PROTECT THE ENVIRONMENT AND BACOR FISHERFOLKS' LIVELIHOOD WHILE ACCOMPLISHING THE BACOR RECLAMATION AND DEVELOPMENT PROJECT (BRDP) PHASE 1.
