A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN AND ENTER INTO A CONTRACT OF LEASE WITH PHILIPPINE LONG DISTANCE TELEPHONE COMPANY (PLDT) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR FOR THE LEASE OF A FIFTY-SQUARE METER PORTION OF THE BACOR CITY HALL BUILDING SITUATED ON ITS LOWER GROUND FLOOR.
