REVILLA, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGION IV-A, THE CITY GOVERNMENT OF BACOR AND IDENTIFIED BARANGAYS REGARDING THE MAINTENANCE AND PROTECTION OF TRASH TRAPS INSTALLED IN THE SAID BARANGAYS.

WHEREAS, on 10 June 2022, the Sangguniang Panlungsod received a letter from the Office of the Mayor requesting that a resolution be passed authorizing the City Mayor to enter into and sign the Memorandum of Agreement between the Department of Environment and Natural Resources (DENR) Region IV-A, the City Government of Bacoor and identified barangays regarding the maintenance and protection of trash traps installed in the said barangays.

WHEREAS, under the proposed agreement, the DENR will provide technical assistance and Communication Education and Public Awareness (CEPA) in rehabilitating, protecting, conserving and managing of waste and waterways relative to the established trash traps. The DENR will also consolidate reports submitted by the barangays involved and by the city government regarding waste collection and disposition to accredited sanitary disposal facilities or sanitary landfills.

WHEREAS, under the draft agreement, the City Government of Bacoor will assist and support the Barangay in conducting weekly or daily clean-up, the weighing, hauling and disposal of the waste trapped and will submit a weekly report to the DENR on the handling, transport and

WHEREAS, the Barangays will enact a Barangay Ordinance, conduct patrolling and monitoring of river/s and waterways to safeguard, for protection and maintenance of the installed trash traps and the cleaned areas from unlawful acts of the residents and submit report to DENR thru the City;

WHEREAS, the City Government of Bacoor together with the Department of Environment and Natural Resources and identified Barangays will designate focal person and jointly implement, monitor and evaluate the performance and condition of the installed trash traps;

WHEREAS, a draft Memorandum of Agreement was submitted by the Office of the Legal Services - with the authority of the City Mayor - to the Sangguniang Panlungsod for review and consideration;

NOW THEREFORE, upon motion of Hon. Levy M. Tela duly seconded by all the members present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to enter into and sign the Memorandum of Agreement between the Department of Environment and Natural Resources (DENR) Region IV-A, the City Government of Bacoor and identified Barangays regarding the maintenance and protection of trash traps installed in the said barangays .

RESOLVED LASTLY, to furnish the Office of the City Mayor, the DENR Region IV-A, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this resolution.
