**WHEREAS**, the said matter was referred to the Committee on Barangay Affairs and the Committee on Ethics and Good Governance for appropriate action.

**WHEREAS**, the Committee on Barangay Affairs and Committee on Ethics and Good Governance conducted a number of hearings attended by the above-mentioned parties with regard the said allegation. At the end of the said hearings, the joint committee recommended to dismiss the said complaint due to lack of merit.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all members present in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor to **DISMISS** the complaint above-mentioned due to lack of merit.
