CITY RESOLUTION NO. 2022-017

A RESOLUTION RESPECTFULLY REQUESTING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ISSUE AN ORDER PROHIBITING PERSONS NOT EMPLOYED AS TRAFFIC AIDES OF THE BACCOOR TRAFFIC MANAGEMENT DEPARTMENT FROM RECEIVING THE INCENTIVES FROM THE BACCOOR TRAFFIC MANAGEMENT TRUST FUND.

WHEREAS, the Sangguniang Panlungsod created the Bacoor Traffic Management Trust Fund through City Ordinance No. 2013-047 (the "Revised Traffic Code of the City of Bacoor") as amended by City Ordinance No. 11-2019.

WHEREAS, Section 56 of the Revised Traffic Code of the City of Bacoor, as amended, provides that:

"Section 56. Creation of the Bacoor Traffic Management Trust Fund. - There is hereby created a Bacoor Traffic Development Trust Fund generated from all receipts from franchising, supervisory and regulatory fees, fines and surcharges as set forth in this Ordinance, including parking charges, terminal fees, towing fees, and similar imposition for specific services rendered.


All payments, collections, and interest earnings of the said Trust Fund shall be directly remitted to the Office of the City Treasurer and the City Accountant shall keep and maintain a special account therefor. All records related thereto shall likewise be in the custody of the City Accountant.

The following incentives to be taken from all the collected fines, fees, surcharges, and interest earnings of the Trust Fund, shall be given to the following at the end of each quarter:

a) Five per cent (5%) to the Traffic Aide/s who did the apprehension to be deemed as additional compensation on top of whatever bonuses or other emoluments that they may receive from the city government;

b) Five per cent (5%) to the barangay/s that implemented the various provisions of the Traffic Code pertaining to the prohibition against jaywalking, illegal parking, illegal terminals, and the removal of illegal structures on all public roads, sidewalks, bridges, parks, and other public areas within the City of Bacoor; and

c) Twenty per cent (20%) of the total accumulated amount in the Trust Fund to be shared equally by all the Units under the BTMD before the end of the fiscal year subject to compliance with all relevant government rules and policies.

The remainder of the Trust Fund shall be disbursed by the BTMD only to finance traffic improvement projects in the City of Bacoor, the operational and training expenses of the BTMD, including the maintenance of its facilities and checkpoints, the purchase of vehicles, uniforms, CCTV and body cameras, and other equipment and the purchase and maintenance of traffic control and safety devices. Any unused balance at the end of the fiscal year in excess of twenty-five percent (25%) of the previous year's expenditures shall revert to the City Government's General Fund."

WHEREAS, as can be gleaned from the said provision, only traffic aides who apprehended violators of the Revised Traffic Code, the barangays that implemented the said

ordinance, and the employees of the BTMD are entitled to receive incentives coming from the Bacoor Traffic Management Trust Fund. The underlying legislative intent behind the said provision is to increase the income of traffic aides and other employees of the BTMD so that the temptation to commit graft and corruption shall be lessened while enhancing the involvement of the various barangays of the City of Bacoor in the implementation of the Revised Traffic Code.

WHEREAS, the reiteration of the foregoing facts became necessary after the Sangguniang Panlungsod learned – after the Committee on Public Transportation and Traffic Management headed by Hon. Roberto L. Advincula conducted a legislative inquiry on the said matter upon the motion of Hon. Reynaldo D. Palabrica – that certain unscrupulous individuals are deliberately conducting baseless traffic related apprehensions of motorists for the purpose of receiving incentives under the Bacoor Traffic Management Trust Fund.

WHEREAS, it was also discovered by the Sanggunian during the said inquiry that the practice of giving out incentives to persons who are not under the employ of the BTMD had been going on for the past few years – in clear violation of the afore-quoted provision of the Revised Traffic Code of the City of Bacoor as amended.

WHEREAS, the said practice is unconscionable as it runs contrary to the reform agenda of the Honorable City Mayor and to his commitment to root out corruption in the City of Bacoor.

NOW THEREFORE, upon motion of Hon. Roberto L. Advincula, unanimously seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled to respectfully request the City Mayor, Hon. Strike B. Revilla, to order the City Accounting Office, the City Treasurer's Office, and the BTMD to discontinue giving incentives under the Bacoor Traffic Management Trust Fund in favor of persons not qualified to receive the same under Section 56 of the Revised Traffic Code as amended.


RESOLVED FURTHER, to respectfully request the City Mayor to conduct an independent inquiry on the above


