WHEREAS, the Sangguniang Panlungsod passed City Resolution No. 2016-019 on February 1, 2016 approving the project proposal of PHINMA Property Holdings Corporation with regard the development and construction of a socialized housing project in the City of Bacoor to be known as "Strikeville 5 Homes" and authorizing then City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement between the said corporation and the city government.

WHEREAS, since the said Resolution was passed, virtually no development work has been done on the proposed site of the said project situated in Barangay Zapote I, Bacoor City, Cavite which has an area of fourteen thousand six hundred eighty five (14,685) square meters.

WHEREAS, the housing shortage in the City of Bacoor needs to be addressed as there are still about 13,000 informal settler families within the city that needs assistance in obtaining decent homes.


WHEREAS, PHINMA's intention to develop and construct the Strikeville 5 Homes must be confirmed by the city government so that the latter can determine what to do with the parcel of land devoted for the said project.





