T-725703 (Block 18, Lot 2) and T-1113082 owned by Spouses Edwin and Theresa Gayle Almirez.

WHEREAS, Household Development Corporation (HDC) donated a parcel of land covered by Transfer Certificate of Title No. T-725703 (Block 18, Lot 2) with an area of Two Thousand Ninety Eight (2098) square meters to the City Government of Bacoor by way of Deed of Donation.

WHEREAS, a portion of the Barangay Hall of Barangay Molino IV was inadvertently constructed on the lot owned by Spouses Almirez located at Block 1 Lot 4 with an area of One Hundred Fifty Four (154) square meters covered by Transfer Certificate of Title No. T-1113082.
