A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT BETWEEN THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE AND THE CULTURAL CENTER OF THE PHILIPPINES REGARDING THE HOLDING OF THE PHILIPPINE PHILHARMONIC ORCHESTRA CONCERT IN THE CITY OF BACOR.

WHEREAS, Section 16 of Republic Act No. 7160 (the "Local Government Code of 1991") empowered local government units to exercise such powers as may be necessary to promote the general welfare and to ensure and support the promotion, preservation, and enrichment of culture.

WHEREAS, the Cultural Center of the Philippines (CCP) is a government owned and controlled corporation that has been at the forefront of the promotion of Philippine culture and the arts since it was created in 1966. Among the performing companies residing within the CCP is the Philippine Philharmonic Orchestra (PPO) – the Philippines' leading orchestra and is widely regarded as one of the best music ensembles in the Asia-Pacific region.

WHEREAS, the CCP and the local government of the City of Bacoor agreed to hold a free concert on 1 August 2022 at the S.T.R.I.K.E. Gymnasium entitled "PPO @ Bacoor, Cavite" in commemoration of the "Bacoor Assembly" that took place on 1 August 1898 where 190 municipal presidents (the equivalent of today's mayors) met in Bacoor to read the *Acta dela Proclamacion dela Independencia del Pueblo* upon the directives of then President Emilio Aguinaldo.


WHEREAS, to formalize the said agreement, the representatives of the CCP and of the City Government signed a Memorandum of Agreement where the obligations




