**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE ACCESSION AGREEMENT AMONG THE CITY GOVERNMENT OF BACOOR, DIAMOND EXPORT CORPORATION, AND DIAMOND SEABANK DEVELOPMENT CORPORATION REGARDING THE DIAMOND RECLAMATION AND DEVELOPMENT PROJECT.**

**WHEREAS**, the city government entered into a Joint Venture Agreement with the Diamond Export Corporation on 20 December 2018 for the undertaking of the Diamond Reclamation and Development Project (the "Project").

**WHEREAS**, under Section 6.4 of the said Joint Venture Agreement, the parties agreed that Diamond Export Corporation may form a Special Purpose Company which will undertake its obligations and be entitled to its rights under the Agreement upon execution of the appropriate Accession Agreement.

**WHEREAS**, the former City Legal Officer, Atty. Maria Bernadette R. Carrasco, with the authority of the former City Mayor, Hon. Lani Mercado-Revilla, formally requested the Sanggunian on 28 April 2022 to pass a Resolution authorizing the City Mayor to sign an Accession Agreement with Diamond Export Corporation and Diamond Seabank Development Corporation regarding the Project.


**WHEREAS**, a copy of the Accession Agreement was submitted to the Sanggunian for its review.
