NOW THEREFORE, after careful deliberation, upon motion of Hon. Alde Joselito F. Pagulayan, unanimously seconded by the council in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize City Mayor, Hon. Strike B. Revilla, to sign a Deed of Donation between the City Government of Bacoor and Alta Land Construction and Development Corporation regarding the donation of the remaining open spaces of Alta Homes Sunnyvale Subdivision with an area of 479 square meters, located in Barangay Molino III, Bacoor City, Cavite.

RESOLVED FURTHER, to furnish the Office of the City Mayor, Alta Land Construction and Development Corporation, the officers of the Homeowners Association of Alta Homes Sunnyvale Subdivision and the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this resolution.
