WHEREAS, Department of Education Secretary and Vice President Sara Duterte issued Memorandum Order No. 034 on 11 July 2022 announcing the School Calendar and Activities for the School Year (SY) 2022-2023 pursuant to the DepEd's "commitment to the resumption of 5 days in-person classes despite the health risks brought on by the COVID-19 pandemic". In the said Memorandum Order, it was provided that classes in all schools in the country shall formally open on 22 August 2022.



WHEREAS, the Sangguniang Panlungsod held a public hearing on 11 August 2022 to inquire into the readiness of the various public schools within the City of Bacoor to contain the possible spread of COVID-19 and other diseases once face-to-face classes resume. One of the resource persons who attended the said hearing was Dr. Edith Atendido, City Schools Division Superintendent of the City of Bacoor.

WHEREAS, after lengthy questioning, Dr. Atendido admitted to the members of the Sanggunian that her office has not been coordinating with the City Health Office regarding the preparation of the infection control plan and containment strategy mentioned above and that the public schools within the City are not prepared to control the spread of COVID-19 or other infectious diseases.

WHEREAS, after hearing the said admissions, the members of the Sangguniang Panlungsod expressed their great disappointment at Dr. Atendido.

WHEREAS, after the said hearing, the members of the Sangguniang Panlungsod unanimously agreed to pass a resolution directing Dr. Atendido to submit the said "Infection Control Plan and Containment Strategy" to the Sanggunian not later than 21 August 2022.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica duly seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled to direct Dr. Edith Atendido, Bacoor City Schools Division Superintendent, to submit to the Sanggunian not later than 21 August 2022 the "Infection Control Plan and Containment Strategy" her office intends to implement to prevent the spread of COVID-19 and other infectious diseases once classes resume on 22 August 2022.
