A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION (DOTr) REGARDING THE TRANSFER OF FUNDS TO THE CITY OF BACOR FOR THE LAND ACQUISITION AND ROAD CONSTRUCTION OF NIOG ACCESS ROAD IN RELATION TO THE LRT PROJECT IN THE CITY OF BACOR, CAVITE.

WHEREAS, on August 12, 2022, the Office of the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting for a resolution authorizing the City Mayor to sign a Memorandum of Agreement with the Department of Transportation (DOTr) regarding the transfer of funds to the City of Bacoor for the land acquisition and road construction of Niog Access Road in relation to the Light Rail Transit (LRT) Project in Bacoor.

WHEREAS, Executive Order No. 125, Series of 1987, as amended, established the DOTr to be the primary policy, planning, programming, coordinating, implementing and administrative entity of the Executive Branch to promote, develop and regulate a dependable and coordinated network of transportation systems.

WHEREAS, the LRT I South (Cavite) Extension Project, is one of the flagship infrastructure projects of the Duterte administration's "Build, Build, Build Program" that will require the construction and land acquisition along the Niog Access Road that will connect from the Railway to the road transport system of the City.

WHEREAS, Republic Act No. 11640 ("AN ACT EXTENDING THE AVAILABILITY OF THE 2021 APPROPRIATIONS TO DECEMBER 31, 2022 AMENDING FOR THE PURPOSE OF SECTION 62 OF THE GENERAL PROVISIONS OF THE REPUBLIC ACT NO. 11518, THE GENERAL
