A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN PERTINENT LOAN DOCUMENTS ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) RELATIVE TO THE TERM LOAN AGREEMENT FOR THE CONSTRUCTION OF A CREMATORIUM/COLUMBARIUM COMPLEX IN THE CITY OF BACOR, CAVITE.

WHEREAS, the City Government of Bacoor entered into a Term Loan Agreement through City Resolution No. 2021-367 dated July 08, 2021 with the Development Bank of the Philippines amounting to One Hundred Fifty Million Pesos (P150,000,000.00) for the construction of a Columbarium/Crematorium Complex.

WHEREAS, the DBP requested that certain amendments in City Resolution No. 2021-367 be made. The said request was approved through City Resolution 2021-441 dated February 14, 2021.

WHEREAS, a letter from the DBP dated July 22, 2022 affirming the approval of a Term Loan amounting to One Hundred Forty-Eight Million Fifty Thousand pesos (Php148,050,000.00) for the construction of Columbarium/Crematorium Complex was received by the Office of the City Mayor. In the said letter, the DBP further requested the city government to submit a resolution authorizing the City Mayor, Hon Strike B. Revilla, to transact and sign Promissory Notes, Disclosure Statements, Certificate of Borrowing, Notice of Borrowing and other loan related documents for the said project.
