A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF UNDERSTANDING BETWEEN THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) AND THE CITY GOVERNMENT OF BACOR RELATIVE TO THE HOUSING PROJECT KNOWN AS THE "PAMBANSANG PABAHAY PARA SA PILIPINO: ZERO ISF PROGRAM FOR 2028".

WHEREAS, Republic Act No. 10160 (otherwise known as the "Charter of the City of Bacoor") established the City of Bacoor as a component city of the Province of Cavite with powers necessary, appropriate and incidental for its efficient governance and essential to the promotion and improvement of the general welfare of the people.

WHEREAS, the City Government of Bacoor commits to establish partnership and cooperation with the other government entities to effectively implement various city development plans and programs among which is the implementation of a Housing Project in the City of Bacoor.

WHEREAS, the Department of Human Settlements and Urban Development is primarily responsible for the management of housing, human settlement and urban development and aims to build one million housing units per year for a total of six million housing units in six (6) years.

WHEREAS, the City of Bacoor recognizes and supports the said program and commits to allocate to the DSHUD a parcel of land for the development of housing projects within its territorial jurisdiction.
