A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY (MMDA) REGARDING THE DEVELOPMENT AND OPERATION OF A FERRY AND BARGE TERMINAL AT BARANGAY SINEGUELASAN, BACoor CITY, CAVITE AS PART OF THE TRAFFIC MANAGEMENT PROGRAM OF THE CITY GOVERNMENT.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, requested the Sangguniang Panlungsod to pass a resolution authorizing him to negotiate with the Metropolitan Manila Development Authority (MMDA) and other government agencies on the development and operation of a ferry terminal at Barangay Sineguelasan as part of his administration's efforts to ease traffic gridlock on various city roads during rush hours.


WHEREAS, in response to the said request, the Sangguniang Panlungsod approved **City Resolution No. 2022-053** entitled: **A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO NEGOTIATE WITH THE DEPARTMENT OF TRANSPORTATION, THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY, AND OTHER GOVERNMENT AGENCIES ON THE CONSTRUCTION, DESIGN, AND OPERATION OF THE PROPOSED FERRY TERMINAL AT BARANGAY SINEGUELASAN, CITY OF BACoor, CAVITE TO SERVE AS AN ALTERNATIVE MODE OF TRANSPORTATION AND TO EASE THE VOLUME OF VEHICULAR TRAFFIC ON VARIOUS PUBLIC ROADS IN THE CITY.**

WHEREAS, as a consequence of the said negotiations, the MMDA agreed to assist the city government in the design and operation of a barge and ferry terminal to be constructed at Barangay Sineguelasan, Bacoor City, Cavite. The terms and conditions of the said collaboration were embodied in a Memorandum of Agreement between the the MMDA and the City of Bacoor.

WHEREAS, after reviewing the said draft contract, the city council expressed its readiness to authorize the City Mayor to sign the same on behalf of the city government considering that once the proposed ferry and barge terminal becomes operational, the said facility will help in significantly reducing the number of motor vehicles on public roads in the City of Bacoor.


