A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE LEASE AGREEMENT WITH THE LANDBANK OF THE PHILIPPINES REGARDING THE LEASE OF OFFICE SPACE AT THE BACOR LEGISLATIVE AND DISASTER RESILIENCY BUILDING ON BEHALF OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE.

**WHEREAS**, the city government was authorized by the Sangguniang Panlungsod to secure a loan worth P530,000,000.00 from Landbank of the Philippines to finance the construction of the Bacoor Disaster Resiliency Building through City Resolution No. 2021-349 which was approved on 10 May 2021.

**WHEREAS**, in order to help pay the said loan, the City Mayor, Hon. Strike B. Revilla, requested the Sanggunian to pass a resolution authorizing him to sign a Lease Agreement on behalf of the City Government with Landbank of the Philippines for the lease of a portion of the above-mentioned building for its banking operations within the City of Bacoor.

**WHEREAS**, on 9 September 2022, the Sangguniang Panlungsod passed a resolution renaming the said building to the "Bacoor Legislative and Disaster Resiliency Building".

**WHEREAS**, the Sanggunian deliberated on the Mayor's request and all its members concluded that the same is not only beneficial for the city government but is also fiscally prudent.
