A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF SOCIAL WELFARE DEVELOPMENT REGION IV-A REGARDING THE DOWNLOADING BY THE LATTER INTO THE BACOOR CITY TREASURY OF SIXTEEN MILLION SIXTY FIVE THOUSAND PESOS (P16,065,000.00) FOR THE SOCIAL PENSION FUND OF SENIOR CITIZENS.

**WHEREAS**, as stipulated in the General Appropriations Act, the DSWD, as a lead agency for social protection is mandated to work towards the achievement of improved capacity and opportunities of the poor, vulnerable, and disadvantaged individuals, families, and communities, to enable them to improve their quality of life, and ensures that government stipends shall be given directly to senior citizen beneficiaries and that the most efficient mode of distribution must be employed.

**WHEREAS**, Social Pension (SocPen) for indigent Senior Citizens is a government assistance mandated under R.A. 9994 (the "Expanded Senior Citizens Act of 2010").


**WHEREAS**, Memorandum Circular (MC) No. 17 Series of 2022 was issued to utilize fund transfer to LGUs in order to fast track the distribution of social pension in accordance with prevailing regulations of the Commission on Audit.

**WHEREAS**, the City Government of Bacoor recognizes its role as mandated thru Republic Act No. 7160 (the "Local Government Code of 1991") to provide services and commits itself to address the needs of the poor including senior citizens.

**WHEREAS**, to ensure the expeditious delivery of assistance to senior citizens, fund transfer to the City Government of Bacoor shall be distributed by authorized LGU personnel to the beneficiaries within thirty(30) days from the receipt of funds, likewise the City Government of Bacoor will take full responsibility in the proper disposition/disbursement of Social Pension funds in accordance with existing accounting and auditing rules and regulations imposed by the Commission on Audit (COA) in Circular No. 94-013, and other applicable accounting and auditing manuals.

**NOW THEREFORE**, upon motion of Hon. Rogelio B. Nolasco, which was unanimously seconded by the City Council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement on behalf of the City Government of Bacoor with the Department of Social Welfare and Development Region IV-A Field Office regarding the downloading by the latter into the City Treasury of the City of Bacoor, Cavite of Sixteen Million Sixty Five Thousand Pesos (P16,065,000.00) for the Social Pension fund.

**RESOLVED FURTHER**, to furnish the City Mayor, Department of Social Welfare and Development Region IV-A Field Office, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this resolution.

**UNANIMOUSLY APPROVED**, this 27<sup>th</sup> day of September 2022 during the 13<sup>th</sup> Regular Session of the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor.
