**WHEREAS**, the City Government of Bacoor (the "City of Bacoor") in partnership with the National Government through the National Housing Authority (NHA) has identified a resettlement site located at Hyacinth Residences and Kristofee Heights both in Barangay Calubcob, Naic, Cavite for the relocation of 1,040 informal settler families from the City of Bacoor.

**WHEREAS**, the Municipal Government of Naic, Cavite (the "Municipality of Naic") supports the City of Bacoor in the relocation of its homeless constituents within the former's territorial jurisdiction.

**WHEREAS**, the Municipality of Naic requested the city government to provide "POST-RELOCATION ASSISTANCE" consisting of basic services, facilities, equipment and financial support which will cater to the needs of the relocated families as identified by the Local Government of Naic, Cavite.

**WHEREAS**, the Office of the City Mayor submitted a draft Memorandum of Cooperation (MOC) to the Sangguniang Panlungsod for its review and consideration.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod in regular session duly assembled to authorize the City Mayor, Hon. Strike B. Revilla, to sign a
