A RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE THROUGH ITS CITY TREASURER'S OFFICE TO ACCEPT DONATIONS TO THE HOUSING TRUST FUND (HTF) FROM NATURAL PERSONS AND JURIDICAL ENTITIES TO BE USED FOR THE BENEFIT OF INFORMAL SETTLER FAMILIES (ISF) AND FOR THE DISTRIBUTION OF FINANCIAL ASSISTANCE TO THE UNDERPRIVILEGED AND HOMELESS FAMILIES AFFECTED BY A COURT ORDERED EVICTION OR DEMOLITION.

**WHEREAS**, Republic Act No. 7279 (the "Urban Development and Housing Act of 1992") provides that the eviction and demolition of informal settler dwellings may only be allowed when it is mandated by a court of competent jurisdiction.

**WHEREAS**, the same law further provides that in the execution of eviction or demolition orders involving underprivileged and homeless citizens, the affected families shall be given financial assistance by the Local Government Unit concerned.

**WHEREAS**, the Sangguniang Panlungsod of the City of Bacoor enacted City Ordinance No. 2013-025 amending Municipal Ordinance No. 13-S-2008 entitled, "An Ordinance Providing for the Institutional, Administrative, and Funding Requirements of the Resettlement and Housing Program of the City of Bacoor".

**WHEREAS**, the City Government of Bacoor pursues a comprehensive, viable, and sustainable urban development and housing program, which shall uplift the living conditions of the deprived sector of the community.

**WHEREAS**, the Housing Trust Fund (HTF) was established to be used for, among others, the distribution of financial assistance to the underprivileged and homeless families affected by eviction and/or demolition pursuant to a court order.

**WHEREAS**, the Housing Trust Fund (HTF) was identified as one of the possible sources of funding in City Ordinance No. 2013-025
