A RESOLUTION RESPECTFULLY REQUESTING CONGRESSWOMAN LANI MERCADO-REVILLA TO INTERCEDE ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO DEPARTMENT OF TRANSPORTATION (DOTr) SECRETARY JAIME J. BAUTISTA REGARDING THE FUNDING FOR THE CONSTRUCTION OF THE PASSENGER FERRY AND FISH TERMINAL AT BARANGAY ALIMA, BACOOR CITY, CAVITE, ESTIMATED TO COST AROUND ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00).

WHEREAS, due to its location at the junction of Cavite and Metro Manila, the City of Bacoor, Cavite has been perennially plagued by daily traffic jams during rush hours. The said traffic gridlocks are so bad that they are affecting the economic growth of the city and of the people doing business within its jurisdiction. Aside from that, the delivery of vital public services are also delayed because of the difficulty of navigating the clogged roads of the City of Bacoor, Cavite to the chagrin of the taxpayers and the commuting public.
