A RESOLUTION RESPECTFULLY REQUESTING CONGRESSWOMAN LANI MERCADO-REVILLA TO INTERCEDE ON BEHALF OF THE CITY GOVERNMENT TO DEPARTMENT OF TRANSPORTATION (DOTR) SECRETARY JAIME J. BAUTISTA TO: (1) RECONSIDER THE LOCATION OF THE LIGHT RAIL TRANSIT (LRT) 1 EXTENSION PROJECT TERMINAL AT THE JUNCTION OF BACOOD BOULEVARD AND AGUINALDO HIGHWAY, (2) TO CONSIDER THE CONSTRUCTION OF ANOTHER LIGHT RAIL TRANSIT (LRT) 1 TERMINAL NEAR THE LOCATION OF THE BACOOD CITY HALL, AND (3) THE FUNDING OF THE RING OF LIFE PROJECT TO BE CONSTRUCTED NEAR THE BACOOD CITY HALL IN ORDER TO IMPROVE THE FLOW OF TRAFFIC NOT ONLY IN THE CITY OF BACOOD BUT FOR THE REST OF CAVITE AND METRO MANILA AS WELL.

WHEREAS, the long awaited completion of the Light Rail Transit (LRT) 1 Extension Project to the City of Bacoor has been touted as the ultimate solution to the traffic management problems of the City. However, Mayor Strike B. Revilla of the City of Bacoor consulted numerous traffic management experts and they all informed him that the proposed location of the terminal of the LRT 1 Extension Project at the junction of Aguinaldo Highway and Bacoor Boulevard — two of the busiest roads in Cavite will negate whatever improvements in travel time that the said project might produce as the influx of tens of thousands of passengers and the motor vehicles they will use to reach the said terminal will effectively block the said intersection during rush hours thus exacerbating further the traffic jams that affect the flow of people and goods from Cavite to Metro Manila and vice versa.

WHEREAS, to find a solution to the potential traffic related problems that the proposed location of the LRT 1 Extension Project might cause, Mayor Strike B. Revilla consulted various stakeholders and they all agreed that the national government must reconsider the location of the said terminal by placing it about 500 meters away from the Aguinaldo Highway-Bacoor Boulevard intersection, by constructing another terminal 3.3 kilometers away from the originally proposed site of aforementioned terminal near the location of the Bacoor City Hall, and by pushing through with the construction of the Ring of Life Project (a traffic roundabout with an elevated road for the exclusive use of pedestrians and bicycles) near the Bacoor City Hall.

WHEREAS, the Sangguniang Panlungsod, in support of the initiatives of the Mayor Strike B. Revilla to spare the City of Bacoor from potentially massive traffic jams if plans related to the construction of the LRT 1 Extension Project terminal are not revised, respectfully requests Congresswoman Lani Mercado-Revilla to intercede on behalf of the city government and request Secretary Jaime J. Bautista of the Department of Transportation (DOTr) to: (1) reconsider the location of the Light Rail Transit (LRT) 1 Extension Project terminal at the junction of Bacoor Boulevard and Aguinaldo Highway, (2) to consider funding the construction of another Light Rail Transit (LRT) 1 terminal near the location of the Bacoor City Hall, and (3) to consider the funding of the Ring of Life project to be constructed near the Bacoor City Hall in order to improve the flow of traffic not only in the City of Bacoor but for the rest of Cavite and Metro Manila as well.
