A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE PROPOSED CONTRACT OF SERVICE BETWEEN THE BACoor CITY GOVERNMENT AND MR. MARK KENNETH D. FRANCISCO IN RELATION TO A PROJECT CALLED: "CITY OF BACoor RIVERWALK AND BIKE LANE MURAL".

WHEREAS, Section 11 of Republic Act No. 10160 (the "Charter of the City of Bacoor"), empowered the Sangguniang Panlungsod to pass measures intended to stimulate tourism, improve the appreciation of culture and the arts, and to promote public health.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, formally requested the Sanggunian to pass a resolution authorizing him to sign a Contract of Service with Mr. Mark Kenneth D. Francisco for and on behalf of the Bacoor City Government.

WHEREAS, a perusal of the draft Contract of Service showed that the Bacoor City Government intends to engage the services of Mr. Francisco for the creation of a mural to be displayed at the Bacoor City Riverwalk and Bike Lane to be known as the "City of Bacoor Riverwalk and Bike Lane Mural".

WHEREAS, under City Appropriation Ordinance No. 199-2022 which was passed on 14 March 2022 by the Sangguniang Panlungsod, ₱400,000.00 was appropriated to the Tourism Promotion Unit for "Other Professional Services".

WHEREAS, when Mr. Edwin Guinto, the officer-in-charge of the Tourism Promotion Unit, was asked during a public hearing conducted by the Committee on Finance and Budget Appropriations what "other professional services" would be

funded by the said ₱400,000.00 he replied that it was intended to pay whoever will be commissioned by the city government to make the aforementioned mural. The City Budget Officer, Ms. Elvinia Guerrero, confirmed the answer given by Mr. Guinto.

WHEREAS, when Mr. Guinto was asked by the members of the said Committee why Mr. Francisco — among all the artists residing in the City of Bacoor and in the Province of Cavite — was chosen to make the said mural, he replied that Mr. Francisco was the one most qualified to perform the said task within the budget allocated for the said project.

WHEREAS, in view of the testimonies given by the resource persons mentioned above, the Committee on Finance and Budget Appropriations moved for the approval of the resolution requested by the City Mayor.

NOW THEREFORE, upon motion of Hon. Rogelio M. Nolasco, duly seconded by the rest of the Body in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod to authorize the City Mayor to sign the Contract of Services with Mr. Mark Kenneth D. Francisco for the creation of "City of Bacoor Riverwalk and Bike Lane Mural" to be installed at the City of Bacoor Riverwalk and Bike Lane at a cost of ₱400,000.00.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the City Budget Officer, Mr. Edwin Guinto, Mr. Mark Kenneth D. Francisco, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
