A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE SUPPLEMENTAL AGREEMENT WITH AQUARIUS SECURITY SERVICES AMOUNTING TO SEVEN HUNDRED SEVEN THOUSAND SEVEN HUNDRED FORTY-THREE AND 92/100 (P707,743.92) COVERING THE WAGE INCREASE MANDATED BY WAGE ORDER NO. IVA-19 IN FAVOR OF SECURITY GUARDS ASSIGNED AT THE GOVERNMENT CENTER OF THE CITY GOVERNMENT OF BACOR, CAVITE.

WHEREAS, a Contract of Agreement between the City Government of Bacoor and Aquarius Security Services was signed last December 27, 2021 for the deployment of fifty-two (52) security guards with a combined salary per annum of Twenty Million Five Hundred Nine Thousand Six Hundred Thirty-Two and 48/100 (P20,509,632.48) for security services rendered from January 1, 2022 to December 1, 2022.

WHEREAS, the Regional Tripartite Wages and Productivity Board for Region IV-A (the "Board") is mandated under Republic Act No. 6727 (otherwise known as the "Wage Rationalization Act") to periodically assess the prevailing regional minimum wages rates and conduct continuing studies to determine whether these are still responsive to the economic condition in the region.

WHEREAS, the said Board approved Wage Order No. IVA-19 entitled: "Providing for A Minimum Wage Increase in Region IV-A" on May 30, 2022 which mandated an adjusted contract rate for security guards working in the CALABARZON area. Consequently, Aquarius Security Services submitted a Supplemental Agreement to the City Mayor which adjusted the salaries of its security guards assigned at the Bacoor Government Center in compliance with the said wage order.

WHEREAS, the City Budget Office remarked that the City Government has sufficient funds to accommodate the wage adjustment made necessary by Wage Order No. IVA-19.
