A RESOLUTION RESPECTFULLY ENDORSING TO SENATOR JUAN EDGARDO M. ANGARA THE PROPOSED PROJECTS AND PROGRAMS FOR 2023-2025 FOR THE DEVELOPMENT OF THE VARIOUS BARANGAYS OF THE CITY OF BACOR, CAVITE FOR POSSIBLE FUNDING BY THE CONGRESS OF THE PHILIPPINES.

WHEREAS, pursuant to Section 287 of Republic Act No. 7160 local government units are mandated to appropriate in its annual budget no less than 20% of its annual National Tax Allotment (formerly known as the Internal Revenue Allotment) for development projects. The said required allocation is commonly known as the 20% Development Fund.
