CITY RESOLUTION NO. 2022-107

Series of 2022

A RESOLUTION DECLARING A STATE OF CALAMITY IN THE CITY OF BACOR, CAVITE CAUSED BY SEVERE TROPICAL STORM PAENG AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILA, TO DISBURSE P30,000,000.00 FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE AND USE ALL OTHER AVAILABLE FUNDS THAT CAN BE LAWFULLY UTILIZED FOR THE PURCHASE OF RELIEF GOODS AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, at around 5:00 p.m. signal number 3 was hoisted by the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) over the CALABARZON area which includes the Province of Cavite due to severe tropical storm Paeng.

WHEREAS, in the early hours of 30 October 2022, the City Disaster Risk Reduction and Management Council (CDRRMC) convened and passed Resolution No. 07 requesting the Sangguniang Panlungsod to declare a state of calamity because 69 of the 73 barangays of the City of Bacoor and around 99, 157 families were affected by the typhoon and to authorize the disbursement of Php 30,000,000.00 from the Disaster Risk Reduction and Management Fund of the City Government for the purchase of relief goods and other incidental expenses related to relief and rehabilitation operations.

WHEREAS, the City Social Welfare and Development Office (CSWDO) and the Bacoor Disaster Risk Reduction and Management Office (BDRRMO) reported to the

Sangguniang Panlungsod, during a special session called by the City Mayor in the afternoon of 30 October 2022, that the number of families residing within the City of Bacoor being evacuated is increasing and that many areas within the City are beginning to get inundated by rising flood waters.

WHEREAS, the members of the Sangguniang Panlungsod noted that the number of city residents afflicted by typhoon Paeng appeared to be greater than those affected by past weather disturbances that wrecked havoc on the city as evidenced by the number of barangays experiencing flash floods and the number of families seeking assistance from the city government.

WHEREAS, the members of the Sangguniang Panlungsod decided to unanimously approve CDRRMC Resolution No. 07 dated 30 October 2022, declare the existence of a state of calamity over the City of Bacoor, Cavite, authorize the City Government to disburse Php 30,000,000.00 from the Disaster Risk Reduction and Management Fund, and empower the City Mayor, Hon. Strike B. Revilla, to make use of the said amount and all other available funds of the City Government for the purchase of relief goods and for incidental expenses related to relief and rehabilitation operations.

NOW THEREFORE, upon motion of Hon. Alde Joselito Pagulayan, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod in special session duly assembled to approve CDRRMC Resolution No. 07 dated 30 October 2022, declare the existence of a state of calamity over the City of Bacoor, Cavite due to severe tropical storm Paeng, authorize the City Government to disburse Php 30,000,000.00 from the Disaster Risk Reduction and Management Fund, and empower the City Mayor, Hon. Strike B. Revilla, to make use of the said amount and all other available funds of the City Government for the purchase of relief goods and for incidental expenses related to relief and rehabilitation operations.

RESOLVED LASTLY, to furnish the CDRRMC, the Office of the City Mayor, the University of the Philippines Office of the National Administrative Register (UP-ONAR), and all other government offices concerned with copies of this Resolution.
