A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN ALL LEGAL DOCUMENTS RELATED TO THE AMENDMENT OF THE PLANNED CONSTRUCTION OF THE "FISHERMAN'S DORMITORY PROJECT" AT BARANGAY SINEGUELASAN AND MODIFY IT INTO A LOCAL ECONOMIC ENTERPRISE TO BE KNOWN AS THE "SINEGUELASAN FISHING VILLAGE" PROJECT OF THE CITY OF BACOR, CAVITE.

WHEREAS, on 16 May 2022, the Sangguniang Panlungsod passed City Resolution No. 2022-460 authorizing then City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Agreement with the Department of Environment and Natural Resources (DENR) regarding the construction a fisherman's wharf and dormitory.

WHEREAS, the said project was proposed in order to provide livelihood opportunities to fisherfolk residing in the City of Bacoor who will be affected by the proposed Diamond Reclamation and Development Project.

WHEREAS, a review of the said project conducted by the City Mayor, Hon. Strike B. Revilla, revealed that more fisherfolk who were economically displaced by the said reclamation project will benefit if the project will be expanded by giving it an eco-tourism component.

WHEREAS, since 2007, the local government of the City of Bacoor has been developing a large tract of foreshore land situated in Barangay Sineguelasan for the cultivation of mangroves not only to promote the growth of aquamarine life and to protect coastal barangays of the city from potential damage caused by storm surges but also as a means of improving the earnings of local fisherfolk.

WHEREAS, developing the said area into an eco-tourism park where the public can enjoy nature and buy affordable aquamarine products will not only provide livelihood opportunities to fisherfolk economically displaced by the reclamation project mentioned
