A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY GOVERNMENT OF BACoor AND SAINT DOMINIC COLLEGE OF ASIA, INC. (SDCA) FOR THE USE OF ITS RURAL HEALTH UNITS AND CLINICS FOR THE CLINICAL PRACTICUM OF SDCA NURSING STUDENTS.

WHEREAS, Section 2 of the Department of Health's Administrative Order No. 5-A, Series of 1996, declares that the production and development of Health Human Resources is necessary for the promotion, maintenance, and delivery of health services.

WHEREAS, under the same Administrative Order, the Department of Health made available its hospitals and accredited government community health resources for the training of students from health professional schools.

WHEREAS, under the Department of Health Rules and Regulations Implementing the Local Government Code of 1991, primary health services are delivered at Rural Health Units, among others.

WHEREAS, the City of Bacoor has within its jurisdiction a Rural Health Unit located at Evangelista Road, Barangay Kaingin, Bacoor City, Cavite.


WHEREAS, the Saint Dominic College of Asia, Inc. (SDCA) is one such health professional school duly recognized by the Commission on Higher Education with Permit No. 064 and registered






WHEREAS, SDCA has expressed its desire to partner with the City Government of Bacoor for the use of its Rural Health Units and Clinics for the Clinical Practicum of its Nursing students.

WHEREAS, on November 28, 2022, the Sangguniang Panlungsod of the City of Bacoor received a request from the City Mayor for authority to enter into and sign a Memorandum of Understanding with SDCA. The proposed Memorandum of Understanding is incorporated herein and is made an integral part of this Resolution.

WHEREAS, under the proposed Memorandum of Understanding, the City Government of Bacoor will undertake to allow the Nursing students of SDCA to use the Rural Health Units and Clinics in the City of Bacoor as part of its Clinical Practicum program.

WHEREAS, under the proposed Memorandum of Understanding, SDCA will be required, among others, to observe the rules set by the City of Bacoor pertaining to student affiliation and to provide a Clinical Instructor for each group of students who will be directly responsible for the students while undergoing clinical practicum. SDCA further agrees under the proposed Memorandum of Understanding that no students will be allowed to undergo their clinical practicum at the Rural Health Units and Clinics unless the students are accompanied and supervised by a clinical instructor.

WHEREAS, the proposed Memorandum of Understanding is in line with the Department of Health's declared policy under Administrative Order No. 5-A, Series of 1996.

WHEREAS, the City Mayor has the power to represent the City in its business transactions and sign in its behalf all contracts upon authority of the Sangguniang Panlungsod under Republic Act No. 7160 or the Local Government Code of 1991 and Republic Act No. 10160 or the Charter of the City of Bacoor.

NOW THEREFORE, upon motion of Hon. Victorio L. Guerrero Jr., unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor to enter into and sign the proposed Memorandum of Understanding with the SDCA.


