WHEREAS, on 15 August 2022, the Sangguniang Panlungsod passed City Resolution No. 2022-046 authorizing the City Mayor, Hon. Strike B. Revilla, to sign the offer of Filinvest LifeMalls for the rent-free use by the City Government of a commercial mall within the Main Square Mall which is situated along Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite.

WHEREAS, as a consequence of the said resolution, the City Government constructed an extension office within the said mall in order to give the public an additional alternative in conducting their transactions with the government.

WHEREAS, the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing him to enter into formal agreements with the head of various national government agencies such as the National Bureau of Investigation, the PhilHealth, the Land Registration Authority, or the Philippine Statistics Authority who might be interested to open satellite branches at the extension office of the City Government inside the Main Square Mall.

WHEREAS, the Sangguniang Panlungsod deliberated on the Mayor's request and found the same worthy of approval as the opening of satellite branches by various
