WHEREAS, on 27 February 2012, the defunct Sangguniang Bayan of the Municipality of Bacoor, Cavite passed Municipal Resolution No. 2012-58 expressing the profound gratitude of the people of Bacoor to former Senator Ramon B. Revilla Sr. for donating a 5,000-square meter lot situated at Barangay Habay 2, Bacoor City, Cavite. The esteemed legislator donated the said parcel of land to enable the municipal government to construct a hospital for the benefit of Bacooreños and of the general public.

WHEREAS, the Bacoor District Hospital was eventually constructed on the lot donated by former Sen. Revilla. The Bacoor District Hospital began serving the public sometime in 2013.

WHEREAS, in 2018, Republic Act No. 11233 upgraded the status of the Bacoor District Hospital into a Level III general hospital to be known as the "Southern Tagalog Regional Hospital" under the direct control and supervision of the Department of Health (DOH).

WHEREAS, on 26 June 2020, Senator Ramon Revilla Sr. passed away at the age of 93.

WHEREAS, the late Senator Revilla Sr. was a legislator and statesman held in high esteem by his colleagues in the Senate who never forgot his roots and strove to improve the lives of his fellow Filipinos in every way possible.

WHEREAS, the legacy of exemplary public service left behind by the departed legislator and leader will be best preserved for the sake of posterity if the Southern Tagalog Regional Hospital shall be renamed in his honor.
