A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE VARIOUS MEMORANDA OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND VARIOUS NATIONAL GOVERNMENT AGENCIES FOR THE USE OF OFFICE SPACES AT MAIN SQUARE MALL AS A BUSINESS ONE STOP SHOP.

WHEREAS, under Republic Act No. 7160 (otherwise known as the "Local Government Code of 1991"), the City Mayor is empowered to allocate and assign office spaces to City and other officials and employees in the City Hall and other buildings owned or leased by the City Government.

WHEREAS, the City Government of Bacoor has an ongoing lease contract with Filinvest Land Inc. for the use of a commercial space within Main Square Mall as an extension office of the City Hall. Since the said mall is situated along Bacoor Boulevard and is near City Hall, the City Mayor intends to establish a Business-One-Stop-Shop at the said extension office which may be used by various national government agencies.

WHEREAS, various government agencies have expressed their interest to establish satellite offices on the said leased property.

WHEREAS, on December 6, 2022, the Sangguniang Panlungsod of the City of Bacoor received a request from the City Mayor for authority to enter into and sign Memoranda of Agreement with various government agencies for the establishment of these satellite offices.


WHEREAS, considering that the aforementioned government agencies are so numerous that it would be an inconvenience for the Office of the City Mayor to seek an authority to sign from the Sanggunian for every single requesting government agency, a






WHEREAS, a review of the said draft memoranda and of the reasons behind the Mayor's request revealed that it would be prudent for the Sangguniang Panlungsod to grant the City Mayor the blanket authority to sign the said Memoranda of Agreements with the said national government agencies so that they may establish satellite offices at the leased property of the city government at Main Square Mall.

WHEREAS, the establishment of these satellite offices would increase the accessibility of the services offered by the said government agencies.

WHEREAS, the City Mayor has the power to represent the City in its business transactions and sign on its behalf all contracts upon authority of the Sangguniang Panlungsod under Republic Act No. 7160 or the Local Government Code of 1991.

NOW THEREFORE, upon motion of Hon. Alde Joselito F. Pagulayan, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor to enter into and sign Memoranda of Agreements with various government agencies for the lease of office space to establish a satellite office at the Main Square Mall.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
