A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE DEED OF DONATION BETWEEN THE CITY GOVERNMENT OF BACOR AND LIGHT RAIL TRANSIT AUTHORITY (LRTA) FOR THE DONATION TO THE CITY GOVERNMENT OF A PARCEL OF LAND SITUATED IN BARANGAY ZAPOTE V CONSISTING OF 718 SQUARE METERS.

WHEREAS, the LIGHT RAIL TRANSIT AUTHORITY (LRTA) is a government owned and controlled corporation organized under Executive Order No. 603, Series of 1980. It wishes to donate a parcel of land situated in Barangay Zapote V consisting of Seven Hundred and Eighteen (718) square meters and is covered by OCT. No. A-S-224 to the City Government of Bacoor because the LRTA no longer needs the property for the implementation of its Line 1 South (Cavite) Extension Project.

WHEREAS, the Sangguniang Panlungsod of the City of Bacoor received a request from the City Mayor for authority to enter into and sign a Deed of Donation with the LRTA for the donation of the said property to the City Government. The proposed Deed of Donation is incorporated herein and is made an integral part of this Resolution.


WHEREAS, under the proposed Deed of Donation, the property donated shall be used by the City Government to relocate its Multi-Purpose Hall and Basketball Court considering that these areas will be directly affected by the implementation of LRTA's Line 1 South (Cavite) Extension Project.






Pagulayan unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor to enter into and sign the proposed Deed of Donation with LRTA for the donation of a parcel of land located in Barangay Zapote V consisting of Seven Hundred and Eighteen square meters.
