CITY RESOLUTION APPROVING THE PARTICIPATION BY THE CITY OF BACOOR, CAVITE IN THE APPLICATION FOR QUALIFICATION AND SELECTION AS PILOT LGU UNDER THE LOCAL GOVERNMENT REFORM PROJECT (LGRP) AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO EXECUTE AND IMPLEMENT A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF LOCAL GOVERNMENT FINANCE (BLGF) FOR THE SAID PURPOSE.

WHEREAS, the Asian Development Bank (ADB) provided funds for the implementation of the Local Government Reform Project (LGRP) to the Government of the Philippines over a period of four (4) years from 2020 to 2024, to "help improve local revenue mobilization, to build the capacity of local government units to deliver local public service, and to strengthen their local governance performance." (Source: LGRP Briefer)

WHEREAS, the project is divided into four (4) expected outputs, one of which is the enhancement of real property tax (RPT) collection of selected Pilot LGUs under the LGRP Component 3. Under the said project component, there will be a targeted assistance of the selected LGUs in the form of coaching and mentoring on the updating of Schedule of Market Values (SMV), tax impact studies, updating of tax maps and assessment records, and the enhancement of collection practices thru the adoption of integrated electronic payment and collections systems.

WHEREAS, the Bureau of Local Government Finance (BLGF) under the Department of Finance (DOF) has been designated as the executing agency of the LGRP, and further designated as among the implementing agencies of the project.

WHEREAS, the City of Bacoor complies with the general requirements of the LGRP, has adequate human and technical resources, is situated in a favorable environment, and firmly commits to participate and support the project that will be implemented by the city government in its territorial jurisdiction.

WHEREAS, the Sangguniang Panlungsod of Bacoor, Cavite shall approve this Resolution and shall authorize the participation of local government of the City of Bacoor in the Pilot LGU component of the LGRP, and shall designate the City Mayor, Hon. Strike B. Revilla, to represent the Local Government Unit (LGU) in the execution and implementation of a Memorandum of Agreement (MOA) with the BLGF to implement the said participation.

WHEREAS, the authority to execute, sign and implement contracts on behalf of the City is vested in the City Mayor, based on a resolution approved by the Sanggunian, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, known as the Local Government Code of 1991, as amended;

NOW THEREFORE, upon motion of Hon. Rogelio Nolasco unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the City of Bacoor's participation in the pilot component of the Local Government Reform Project (LGRP) as implemented by the Bureau of Local Government Finance (BLGF), to provide adequate resources as counterpart contribution of the LGU in the said project, and to appropriate sufficient funds to support its participation thereto.


RESOLVED FURTHER, the Sangguniang Panlungsod authorizes the City Mayor, Hon. Strike B. Revilla, to execute and implement the Memorandum of Agreement with the BLGF, to participate and support the pilot LGU component of the LGRP output 3, and apply for qualification and selection as pilot LGU, to implement this resolution.


