T-315018 and 057-2012007392 registered in the Registry of Deeds, Province of Cavite located at the Ciudad de Strike Community, Barangay Molino I, City of Bacoor, Cavite and consisting of the following areas: (1) Two Thousand Eight Hundred Twenty Three (2,823) square meters and (2) One Thousand Three Hundred Seventy One square meters and Seventy Two decimeters (1,371.72) respectively;

WHEREAS, the Social Housing Finance Corporation intends to transfer and convey by way of donation of aforementioned portions of open spaces to the city government because of the multi-purpose building and school building that were constructed by the latter on the said open spaces.

WHEREAS, a draft Deed of Donation covering the said lots was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.


