CITY RESOLUTION NO. CR 2022-433
Series of 2022

A RESOLUTION ALLOWING THE BACOOR TRAFFIC MANAGEMENT DEPARTMENT (BTMD) TO DISPOSE OF UNCLAIMED IMPOUNDED VEHICLES THROUGH THE CONDUCT OF A PUBLIC AUCTION.

WHEREAS, on 14 December 2021, the Office of the City Legal Service endorsed the letter-request of the Bacoor Traffic Management Department (BTMD) for the disposal of unclaimed impounded vehicles together with the inventory of the said properties to the Sangguniang Panlungsod for legislative action and issuance of resolution allowing to dispose the said impounded vehicles.

WHEREAS, under Section 125 of the City Ordinance No. 2013-047, the BTMD has the authority to dispose the impounded vehicles, in this manner:

"a) The Traffic Operations Officer is hereby authorized to recommend to the City Mayor the disposal of a vehicle that has been taken into custody. Such disposition shall be through public auction under such procedure, as the City Mayor shall establish with the approval of the Sangguniang Panlungsod. Written notice of such auction shall be sent to the last known registered owner by registered mail at least ten (10) days prior to the date of auction, and said auction shall be held not earlier than 60 days after the date the vehicle shall have been taken into custody. Any person entitled to such vehicle may claim the same at any time prior to such auction upon payment of all costs and expenses relating to the towing and storage of such vehicle, as determined by the Traffic Operations Officer or his authorized subordinates.

(b) The proceeds derived from such auction shall be used to defray the expenses of auction and any other expenses incurred in the towing and storage of the vehicle. The balance if any, shall accrue to the Bacoor Traffic Management Trust Fund."


