
WHEREAS, the Office of the Sangguniang Panlungsod is in need of three (3) motor vehicles to update its aging fleet of service vehicles.



Nolasco in regular online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the purchase of three (3) motor vehicle units for the Sangguniang Panlungsod Office of the City Government of Bacoor. **Provided that:** the said purchase conforms with the DILG Memo Circular No. 2021- 004 dated 18 January 2021 and – as part of the austerity measures being implemented by the city government to maximize the use of limited public funds for the greater good – the cost of the said vehicle should **not** exceed Php 1,200,000.00.

RESOLVED FURTHER, to authorize the City Mayor to sign all agreements or documents related to the said purchase that complies with the foregoing conditions.


