A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE DENR THROUGH THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE OF THE PROVINCE OF CAVITE REGARDING THE CONSTRUCTION OF A FISHERMAN'S WHARF AND DORMITORY IN THE CITY OF BACOR, CAVITE SUBJECT TO CERTAIN CONDITIONS.

WHEREAS, the city government and **Diamond Export Corporation** ("DEC") entered into a Joint Venture Agreement on 20 December 2018 for the reclamation and land development of 100 hectares, more or less, of the offshore areas in Bacoor Bay – a project that became known as the **Diamond Reclamation and Development Project** (the "DRDP").

WHEREAS, in a letter dated 20 November 2018, the Bureau of Fisheries and Aquatic Resources (BFAR) stated that it was not objecting to the DRDP if fisherfolk that will be affected by the said project will be compensated – among other conditions.

WHEREAS, in partial compliance with the conditions set forth by the BFAR as mentioned above, the city government intends to construct a **Fisherman's Wharf and Dormitory** (the "Project") within the territorial jurisdiction of the City of Bacoor.

WHEREAS, a draft Memorandum of Agreement between the city government and the Department of Environment and Natural Resources (DENR) through the Provincial Environment and Natural Resources Office of the Province of Cavite ("PENRO") regarding the Project to be constructed on the DRDP was submitted by the City Legal Officer of the City of Bacoor to the Sangguniang Panlungsod for review and approval.

WHEREAS, upon review of the said MOA, the Sangguniang Panlungsod unanimously resolved to authorize the City Mayor to sign the said Agreement on behalf of the city government subject to certain conditions.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica, duly seconded by Hon. Hernando Gutierrez, Hon. Rowena Bautista-Mendiola, and Hon. Alejandro F. Gutierrez, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 4th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular online session duly assembled to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign the Memorandum of Agreement between the city government and the Department of Environment and Natural Resources (DENR) through the Provincial Environment and Natural Resources Office of the Province of Cavite ("PENRO") regarding the Fisherman's Wharf and Dormitory to be constructed on the DRDP. **Provided that:** the Memorandum of Agreement must explicitly provide that:

- (a) The Fisherman's Wharf and Dormitory (the "Project") shall be owned, managed, operated, and maintained by the city government in perpetuity;
- (b) Fisherfolk residing and/or working in the City of Bacoor, Cavite who shall be affected by the DRDP shall be the main beneficiaries of the Project and shall be prioritized in the use of the Project's various services and facilities over other fisherfolk residing or working in other localities; and
- (c) All plans, designs, budget proposals and all other technical matters related to the development, construction, financing, management, operation, and maintenance of the Project and its various components shall be submitted to the Sangguniang Panlungsod for approval before they are implemented.
