**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, AND THE OIC-CITY TREASURER, ATTY. JESSON G. LABAO TO OPEN THREE (3) SEPARATE TRUST FUND ACCOUNTS INTENDED FOR THE TRANSFER OF FUNDS TO THE CITY GOVERNMENT OF BACOOR FROM THE DEPARTMENT OF TRANSPORTATION (DOTr) FOR THE FOLLOWING SPECIFIC ACTIVITIES STATED IN THE MEMORANDUM OF AGREEMENT NAMELY: (1) RELOCATION AND RESETTLEMENT OF PROJECT-AFFECTED INFORMAL SETTLER FAMILIES; (2) LAND ACQUISITION AND ROAD CONSTRUCTION OF NIOG ACCESS ROAD; AND (3) REMOVAL, RELOCATION AND/OR RESTORATION OF AFFECTED STRUCTURES AND AUXILIARIES.**
