**A RESOLUTION AUTHORIZING CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND FARMACIA NI DOK FOR THE PROVISION OF FREE PRESCRIPTION DRUGS AND MEDICINES TO THE INDIGENT RESIDENTS OF THE CITY OF BACOR, CAVITE**

**WHEREAS**, the City Government of Bacoor has a responsibility to protect and promote the physical health and well-being of all Bacoorenos, especially those in vulnerable sectors such as indigent residents.

**WHEREAS**, indigent residents, due to their meager salaries, are unlikely to be able to consistently and reliably afford prescription drugs for their personal needs.

**WHEREAS**, in fact, through a letter dated 9 January 2023, the Office of the City Mayor reported that numerous indigent residents have requested this administration for assistance with respect to their medical needs and to provide free prescription drugs and medicine.

**WHEREAS**, the abject situation of indigent city residents behooves the City Government to form partnerships with local legitimate pharmaceutical companies in order to better extend to the former free prescription drugs and medicines.

**WHEREAS**, *Farmacia ni Dok*, a local drug retailer, has expressed its interest to partner with the City Government of Bacoor for the provision of said drugs and medicines.

**WHEREAS**, in the same letter dated 9 January 2023, the Office of the City Mayor requested for authority to sign a proposed Memorandum of Agreement with *Farmacia ni Dok*. The proposed Memorandum of Agreement would form a partnership between the City Government of Bacoor and *Farmacia ni Dok* in which the latter would provide prescription drugs and medicines to qualified indigent beneficiaries at no cost to the indigent residents. The proposed Memorandum of Agreement obligates the City

Government to pay for the costs, charges, expenses, and fees incurred by *Farmacia ni Dok* in the provision of these drugs and medicines. This arrangement will be implemented under the **Strike sa Serbisyo Action Program**.

The proposed Memorandum of Agreement is deemed incorporated herein and made an integral part of this Resolution.

**WHEREAS**, the proposed Memorandum of Agreement, if signed and implemented as written, provides a great benefit to indigent residents of Bacoor by helping them acquire the medical goods they need to sustain a healthy life. On the other hand, the signing and implementation of the proposed Memorandum of Agreement also benefits the City Government of Bacoor by reducing the implementation costs of the Strike sa Serbisyo Action Program by letting *Farmacia ni Dok* supply the prescription drugs and medicines.

**WHEREAS**, the signing and implementation of the proposed Memorandum of Agreement is consistent with the duty of the City Government of Bacoor under its charter (Republic Act No. 10160) to ensure the provision of basic services including those that promote the health of its residents.

**WHEREAS**, the City Mayor has the power to represent the City in its business transactions and sign on its behalf all contracts upon authority of the Sangguniang Panlungsod under Republic Act No. 7160 or the Local Government Code of 1991.

**NOW THEREFORE**, upon motion of Hon. Alde Joselito Pagulayan, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor to sign the proposed Memorandum of Agreement between the City Government of Bacoor and *Farmacia ni Dok* regarding the provision of free prescription drugs and medicines to qualified indigent residents.

**RESOLVED LASTLY**, to furnish *Farmacia ni Dok*, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.

**APPROVED** on the 16th day of January 2023 at the City of Bacoor, Cavite by the Sangguniang Panlungsod of the City of Bacoor.
