A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND THE PAROLE AND PROBATION ADMINISTRATION (PPA) REGARDING THE ESTABLISHMENT OF A LOCAL PAROLE AND PROBATION OFFICE AT THE BACOR CITY GOVERNMENT CENTER.

WHEREAS, an effective parole and probation system is necessary to promote the reformation and rehabilitation of criminal offenders, to reduce the incidence of recidivism, and to provide a cheaper alternative to the institutional confinement of first-time offenders.

WHEREAS, the Parole and Probation Administration (PPA) was created by Presidential Decree No. 968 (P.D. No. 968) in order to establish such a system.

WHEREAS, under the Revised Administrative Code of 1987, government agencies such as the PPA are authorized to establish offices in service areas across the country. Thus, to carry out the objectives of P.D. No. 968, the PPA established Provincial and City Probation and Parole offices.

WHEREAS, according to a report penned by Frances F. Magnaan, the Assistant Regional Director/Regional Officer-in-Charge of the PPA in the National Capital Region, there is a lack of infrastructure for the implementation of its programs. Specifically, the report mentions that there is a lack of "appropriate and conducive office space, technology, and resources" devoted for activities related to parole and probation. Moreover, the same report mentioned that the PPA requires facilities necessary for its decentralization thrust to provide added convenience to the transacting public.

WHEREAS, on 9 January 2023, the Sangguniang Panlungsod received a request from the Office of the City Mayor for a resolution authorizing the City Mayor to sign a proposed Memorandum of Agreement between the City Government of Bacoor and the PPA for the creation of a local Parole and Probation Office in the Bacoor Government Center.

The proposed Memorandum of Agreement is deemed incorporated herein and made an integral part of this Resolution.

WHEREAS, under the proposed Memorandum of Agreement, the City of Bacoor will provide the PPA with an office space located in the NAC Building in the Bacoor Government Center Compound. The office shall serve as a local Parole and Probation Office. Furthermore, the City of Bacoor will provide the PPA with necessary equipment and support personnel. On the other hand, the PPA shall investigate all applicants for probation, parole, and pardon who are residents of Bacoor City and exercise supervision over probationers, parolees, and pardonees who are residents of the City.

WHEREAS, the proposed Memorandum of Agreement, if signed and implemented as written, provides a great benefit to residents of Bacoor and the City Government by making the application for probation, parole, and pardon more convenient to qualified applicants and shall contribute to the improvement of the administration of justice.

WHEREAS, the signing and implementation of the proposed Memorandum of Agreement is consistent with the duty of the City Government of Bacoor under its charter (Republic Act No. 10160) to maintain peace and order by enacting measures to prevent and suppress lawlessness.

WHEREAS, the City Mayor has the power to represent the City in its business transactions and sign on its behalf all contracts upon authority of the Sangguniang Panlungsod under Republic Act No. 7160 or the Local Government Code of 1991.

NOW THEREFORE, upon motion of Hon. Alejandro F. Gutierrez unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor to sign the proposed Memorandum of Agreement between the City Government of Bacoor and the Parole and Probation Administration regarding the creation of a local Parole and Probation Office in the Bacoor Government Center Compound.

RESOLVED LASTLY, to furnish the Parole and Probation Administration, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.


