A RESOLUTION DISMISSING THE COMPLAINT OF MS. HEMELEN B. BULAON OF BARANGAY QUEEN'S ROW EAST, BACOOR CITY, CAVITE AGAINST MR. SIEGFRED DE LEON, PUNONG BARANGAY OF THE SAME BARANGAY DUE TO LACK OF INTEREST OF THE FORMER TO PROSECUTE AND LACK OF EVIDENCE.

WHEREAS, on 12 August 2022, a complaint was filed by Ms. Hemelen Bulaon of Barangay Queen's Row East, Bacoor City, Cavite, (the "complainant") against Mr. Siegfred De Leon, Punong Barangay of the same Barangay (the "respondent") for alleged abuse of authority.

WHEREAS, the said matter was referred to the Committee on Ethics, Appointments and Government Reorganization for appropriate action.

WHEREAS, the Committee on Ethics and Appointments and Government Reorganization conducted number of hearings attended only by the respondent with regard the said allegation. The complainant did not attend any of the said hearings as all attempts to locate her at her last known address failed. Moreover, the complainant failed to submit any evidence to corroborate her various allegations despite being given every opportunity to do so. At the end of the last hearing, the said committee recommended to dismiss the complaint due to the lack of interest of the complainant to prosecute the administrative action she filed and due to her failure to present convincing evidence in support of her allegations.
