**A RESOLUTION PROVISIONALLY DISMISSING THE COMPLAINT OF MR. DOMINADOR A. ALFON OF BARANGAY SAN NICOLAS III, BACOOR CITY, CAVITE AGAINST MS. LEONORA FRIAS, SANGGUNIANG BARANGAY MEMBER OF THE SAME BARANGAY DUE TO THE COMPLAINANT'S UNKNOWN ADDRESS.**

**WHEREAS**, on 09 December 2022, the Sangguniang Panlungsod received a letter from the Department of the Interior and Local Government (DILG) – Bacoor endorsing a letter of complaint of Mr. Dominador Alfon (the "complainant") against Ms. Leonora Frias, Sangguniang Barangay Member of Barangay San Nicolas III, City of Bacoor (the "respondent") for alleged grave coercion, grave abuse of authority and grave misconduct for selling the land of the complainant to a third party without the latter's permission.

**WHEREAS**, the said matter was referred to the Committee on Ethics, Appointments and Government Reorganization for appropriate action.

**WHEREAS**, the Committee on Ethics, Appointments and Government Reorganization conducted hearings on January 19 and 26, 2023 attended only by the respondent with regard the said allegation. The complainant did not attend any of the said hearings. Several attempts to locate the complainant at his last known address failed prompting the said Committee to recommend the dismissal of the said complaint.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica duly seconded by the rest of the Body in regular session duly assembled, **BE IT RESOLVED AS IT IS**
