A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH THE COMMISSION ON POPULATION AND DEVELOPMENT – REGION IVA CALABARZON, AND THE BACOR NATIONAL HIGH SCHOOL FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR REGARDING THE ESTABLISHMENT OF SCHOOL-BASED TEEN CENTER IN ONE OF THE NATIONAL HIGH SCHOOLS IN THE CITY OF BACOR NAMED AS "ISCOOL TEEN CENTER (ITC)".

**WHEREAS**, on 30 January 2023, the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting that a resolution be passed authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with the Commission on Population and Development – Region IVA (POPCOM –CALABARZON), and Bacoor National High School for and on behalf of the City Government of Bacoor.

**WHEREAS**, the POPCOM - CALABARZON is directed to coordinate with relevant national government offices and Local Government Units (LGUs) for the intensified implementation of the Philippine Population Management Program (PPMP) and ensure that young people/adolescents are provided with knowledge and education and services on population, development and reproductive health.

**WHEREAS**, the City Government of Bacoor through Hon. Strike B. Revilla has initiated the establishment of a school-based teen center in one of the national high schools in the City of Bacoor to be named as "IsCool Teen Center (ITC)" or the "Project".

**WHEREAS**, the City Government of Bacoor, the POPCOM and the Bacoor National High School have agreed to undertake the said project under the terms and conditions stated in the draft Memorandum of Agreement that was sent to the city council for its review.

**NOW THEREFORE**, upon motion of Hon. Alde Joselito Pagulayan unanimously seconded by all the councilors present in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with the Commission on Population and Development – Region IVA and the Bacoor National High School for and on behalf of the City Government of Bacoor, Cavite.





# MEMORANDUM OF AGREEMENT

## KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "Agreement") is made and entered into this \_\_\_ day of \_\_\_\_\_ 2022 at the City Government of Bacoor, Province of Cavite, by and among:

The **COMMISSION ON POPULATION AND DEVELOPMENT – REGION IVA CALABARZON**, a government entity organized and existing under and by virtue of the Philippine laws with principal office address at the 2<sup>nd</sup> Floor, POPCOM Building, Welfareville Compound, Acacia Lane, Mandaluyong City, represented herein by its Acting Regional Director, **MARILYN F. OGAYA, MADem**, and hereinafter referred to as the "**POPCOM**"

- and -

The **CITY GOVERNMENT OF BACoor**, a local government unit duly organized and existing under the laws of the Republic of the Philippines, with principal office address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Province of Cavite, represented herein by its City Mayor, Hon. **STRIKE B. REVILLA**, and hereinafter referred to as the "**LGU BACoor**"

- and -

The **BACoor NATIONAL HIGH SCHOOL**, a duly organized educational institution with principal school address at Molino Road, Buroi, Bacoor City, Province of Cavite, represented herein by its Principal IV, **Mr. TEODORO A. GLORIANI EdD**, and hereinafter referred to as the "**BNHS**"

"Party" shall mean POPCOM, LGU BACoor or BNHS, if applicable, while the term "Parties" shall mean POPCOM, LGU BACoor and BNHS, collectively.

## WITNESSETH:

**WHEREAS**, POPCOM as the agency mandated to be the over-all coordinating body for the *Philippine Population Management Program (PPMP)*, a nationwide government program that is being implemented by various national and regional line agencies, local government units, non-government organizations and people's organizations;

**WHEREAS**, one of the major program thrusts of the PPMP is to ensure that young people/adolescents are provided with appropriate information, knowledge, education and services on population, development and reproductive health;

**WHEREAS**, in promoting the program thrusts, for young people/adolescents, for young people/adolescents, POPCOM, through its regional offices, is partnering and collaborating with various stakeholders to pilot, implement, coordinate, and establish relevant programs addressing adolescents issues and concerns;

**WHEREAS**, POPCOM entered into a tri-partnership agreement and collaboration with LGU BACOR and BNHS, to undertake the sustainability of the school-based teen center, named "IsCool Teen Center (ITC)" or the "Project";

**WHEREAS**, LGU BACOR, through its Chief Executive, Hon. Strike B. Revilla, has identified and initiated the establishment of school-based teen center in one of the largest national high schools in the City of Bacor;

**WHEREAS**, BNHS, being the largest national public high school in the City of Bacor, through its Principal IV, Mr. Teodoro A. Gloriani, EdD, has willingly agreed for the sustainability of the said school-based teen center to be managed and operated by the concerned teachers and selected students from BNHS;

**WHEREAS**, LGU BACOR and BNHS as pilot local government unit and institution, respectively, will benefit from the project by enabling the growing youth population, particularly the students of BNHS, towards improved and responsible behavior and therefore shaping these young people to become productive individual of the province and of this country;

**NOW, THEREFORE**, for and in consideration of the abovementioned premises, POPCOM, LGU BACOR and BNHS have mutually agreed to undertake the Project under the following terms and conditions:

**I. OBLIGATIONS OF POPCOM:**

1. Coordinate and consult with LGU BACOR and BNHS for the establishment, operationalization, and maintenance of the IsCool Teen Center;
2. Provide financial assistance in terms of capacity and capability building of the Management Committee members of the IsCool Teen Center;
3. Provide counterpart funding to help defray some costs in the sustainability of the center (e.g., ID, uniform of the Management Committee, and youth volunteers, supplies and related materials);
4. Provide technical assistance to the IsCool Teen Center Management Committee in the conduct of trainings on AHYDP related and parenting classes as well as in the formulation of relevant core messages and the like;
5. Monitor and evaluate the performance of the teen center, together with the concerned members of Management Committee comprised of concerned teachers and students and local population personnel; and
6. Assist both LGU BACOR and BNHS technical and operational guidelines/procedures to enable them to operate effectively and efficiently.

**II. OBLIGATIONS OF LGU BACOR:**

1. Exercise the oversight functions and will give the general directions for the Project;
2. Provide counterpart funding for the construction or repairs of the teen center building as well as its equipment and maintenance of its facilities. However, LGU BACOR may opt to utilize a dedicated classroom within BNHS premises for the implementation of the Project;

3. Through the local population officers, will assist and monitor the implementation of the project work plans (which define activities) as agreed upon with LGU BACoor and POPCOM;
4. Empower and strengthen the IsCool Teen Center Management Committee officers and members;
5. Develop and improve the municipal development plan/local investment program by inclusion of annual budgetary support to maintain and sustain the IsCool Teen Center;
6. Institutionalize the IsCool Teen Center as well as its support activities in LGU BACoor by:
  - a. Allocation of regular budget for maintenance and sustainability of the school based teen center;
  - b. Coming out with the appropriate mechanisms for the institutionalization of the Project;
  - c. Provision of resources for monitoring the operation of the Center; and
  - d. Application of appropriate mechanisms for its replication to other areas in the locality.

### **III. OBLIGATIONS OF BNHS:**

1. Ensure the implementation of the project work plans (which define activities under AHYD-IsCool Teen Center Plan) as agreed upon with LGU BACoor and POPCOM;
2. Mobilize the concerned teachers and students to achieve project objectives;
3. Provide the needed assistance/guidance based on tripartite agreements;
4. Maintain the Teen Advises as IsCool Teen Center Coordinator and assign Guidance Counselor as Alternate IsCool Teen Center Coordinator, thereby linking the IsCool Teen Center to the Guidance Council. They shall have the following functions:
  - a. Prepare and submit the needed documentation reports (written and photos/videos) through the Management Committee officials;
  - b. Perform other project-related functions that may be assigned by the tripartite partners.
5. Conduct activities mutually agreed upon.

### **IV. EFFECTIVITY.**

This MOA shall take effect upon signing of all the Parties and shall remain in full force for a period of \_\_\_\_ ( ) years or until \_\_\_\_\_ for the purpose for which it was created.
