WHEREAS, by virtue of City Ordinance No. 234-2022 (CO 234-2022), the local economic enterprise known as the **Molino Public Cemetery, Crematorium, Columbarium, and Chapel** (the "Facility") was created pursuant to Sections 22 and 325 of Republic Act No. 7160 (the "Local Government Code of 1991").

WHEREAS, Section 5 of CO 234-2022 appointed the City Mayor of the City of Bacoor, Cavite as the Chief Executive Officer of the Facility while the members of the Sangguniang Panlungsod constituted themselves as the Board of Directors thereof pursuant to Section 6 of the said ordinance.

WHEREAS, CO 234-2022 became effective on 10 October 2022.

WHEREAS, pursuant to Section 4 of Republic Act No. 10160 (the "Charter of the City of Bacoor") one of the general powers of the City is to exercise all powers as are granted to corporations. One of the powers granted to corporations is to call for the convening of its Board of Directors.

WHEREAS, in view of the foregoing, there is a need to convene the Board of Directors of the Facility so that it can begin performing its various duties under CO 234-2022.
