WHEREAS, on 02 February 2023, the Zoning and Land Development Department sent a letter request to the Sangguniang Panlungsod to pass a resolution authorizing the application of Special Patents by the city government for various public schools in the City of Bacoor. Once the said application is approved, the titles shall be issued in the name of the City Government of Bacoor followed by the name of the school.

WHEREAS, the following public schools shall be the subject of the said application for special patents:

- a) Dulong Elementary School – Dulong Bayan, Bacoor City; and
- b) Sineguelasan Elementary School – Sineguelasan, Bacoor City.

WHEREAS, after a careful deliberation of the abovementioned matter the Chairperson Victorio L. Guerrero, Jr. of Committee on Education, Science and Technology recommended the passage of a resolution authorizing the city government to apply for special patents in order to make possible the titling of the lands on which the said schools stand under the name of the City of Bacoor, Cavite;


- a) City Government of Bacoor (Dulong Bayan Elementary School – Dulong Bayan, Bacoor City); and
